Property

Essential cover that offers protection to your building and contents against fire, explosion, earthquake, storm and tempest, impact, vandalism, riots and strikes, water leakage and accidental damage. Optional flood benefit is also available.

Business Interruption

Protects your business and covers you for loss of profits or gross income resulting from interference to the business as a result of loss or damage to insured property following an insured event.

Theft

For loss or damage to contents or stock which occurs as a result of forcible entry.

Broadform Liability

Cover for compensation in respect of personal injury for non-employees or property damage caused by an occurrence in connection with your business.

Tax Audit Cover

Money

Loss or damage to money belonging to you and connected with the business can be covered. Various levels of cover are available: e.g. in transit to or from the bank; during business hours; outside of business hours; whilst locked in a safe; and in private residences.

Machinery Breakdown

Cover for incidents of breakdown of any plant and equipment item.

Electronic Equipment

Cover for damage to electronic plant or equipment.

Glass

Cover for breakage of fixed glass at the location specified for which you are legally responsible.

General Property

Cover for loss or damage to property away from the premises as a result of sudden and unforeseen accident or circumstance.

Transit

Damage to property insured whilst in transit in Australia.
